Lions Community Park Pavilion Reservation Application

This is your reservation which will be confirmed upon receipt of the charges listed below. These fees must be received in our office by _____, (14 days from the date your reservation was submitted, or it will be cancelled.)

Should the rules and regulations associated with the park not be followed, the permit holder **may not** be refunded the deposit and/or **may be** charged for any additional costs the Village incurs to adequately pick up and clean the park restrooms, including the disposal of garbage, replacement of the horseshoes, damage to the facilities, and costs associated with rekeying the locks due to the loss of a key. Deposits not claimed by December 1st will be forfeited. Failure to comply with the rules and regulations may also affect permission for future use of the park.

The rental group **must** keep a copy of the rental agreement in their possession at all times during their rental for verification of use.

A \$5.00 administrative fee is charged for all cancellations. Refunds are issued for cancellations made at least 14 days prior to the reservation. No refund is given if a reservation is not used due to weather.

RULES AND REGULATIONS FOR PARK RENTALS

RESERVATION POLICIES

1. Reservations will be accepted for the current calendar year only.
2. Reservations may be made by mail, phone or in person at the Dimondale Village Office, 136 N. Bridge St.
3. Reservations are not confirmed until payment is received.
4. All applications will be considered on a first-received basis.
5. Persons must be 18 years of age or older to reserve the pavilion.
6. The restroom key may be picked up at the Village Office the week prior to the reservation date and must be returned within one week of pavilion use. If the key is not returned, the \$25.00 deposit will be retained by the Village.

PAVILION RULES

1. Park hours are dawn to dusk, unless posted otherwise.
2. No alcoholic beverages are allowed.
3. No motorized vehicles are allowed in the park.
4. No bikes, skateboards or rollerblades are allowed in the pavilion.
5. Fires are permitted only in picnic grills.
6. Picnic tables must remain on the concrete.
7. Garbage must be placed in the barrels provided. **PLEASE DO NOT REMOVE BAGS FROM BARRELS.**

PARK RULES

1. Park hours are dawn to dusk year round.
2. It is unlawful to destroy park property.
3. Fires are permitted only in picnic grills.
4. Owners must keep pets on a leash of a length no more than six feet and are responsible for cleaning up droppings.
5. Hunting and trapping are prohibited.
6. It is unlawful to feed the wildlife.
7. All motorized vehicles must remain in designated parking areas except those for handicapped accessibility.
8. Peddling and soliciting are prohibited.
9. Alcoholic beverages are prohibited.
10. It is unlawful to litter or pollute any park area or waterway.
